REPRODUCTION AND USAGE POLICIES FOR COPYRIGHTED TAROT CARD IMAGES

Yasmeen Westwood Art owns the copyrights on the Tarot decks that it publishes including what is known as "electronic reproduction rights," which include the scanning of cards for display via computer platforms, electronic devices and the Internet.

GENERAL POLICIES REGARDING REPRODUCTION AND USAGE

1. If approved, permission for the reproduction and usage of Tarot Deck images shall be granted for specific Tarot Decks only.
2. Permission is subject to review and approval of the Application for Permission to Reproduce and Use Tarot Card Images (above). If your application is approved an Permission Agreement To Reproduce and Use Tarot Card Images, which contains the terms of the authorised use will be provided to you for signature. Thereafter, your permission to electronically reproduce and use Tarot Card images shall become effective upon receipt by Yasmeen Westwood Art of all applicable fees, which shall be paid by check or credit card.
3. Tarot Card images shall not be altered in any way except for possible loss of resolution due to electronic display of such images, unless otherwise authorised.
4. All use of Tarot Card images shall be accompanied by a Yasmeen Westwood Art, as specified in the Permission Agreement.
5. Authorised use shall be for the duration of the specific production or event described in the Agreement or for a period not to exceed two years. Application to renew permissions for authorised use may be submitted up to six months prior to the expiration of the two-year permission period, unless otherwise authorised.

USAGE AND PRICING

1. Tarot Deck Marketing. (Example: Reproduced Tarot Card images used solely to advertise or promote the sale of Tarot Cards, Decks or other products manufactured or distributed by Yasmeen Westwood Art).

Fees: Free of charge with attribution

2. Tarot Deck Reviews. Example: Tarot Card images used solely to facilitate or enhance reviews of Tarot decks via print or interactive media not involving or facilitating Tarot readings.

Fees: Free of charge with attribution

3. Free Tarot education. Instructional materials used to teach about Tarot, including articles, without a commercial aspect and not involving or facilitating Tarot readings of any kind.

Fees: Free of charge with attribution

4. Moving Media: Reproduced images of Tarot Cards for display in film, television shows, videos, TV advertisements or multimedia presentations. Fees: Fee for Usage

5. Commercial Tarot education. Instructional materials used to teach about Tarot, including articles, wherein students are charged fees, not involving automated self-service Tarot readings. Fees: Fee for Usage.

6. Printed Materials. Reproduced images of Tarot Card images for display in a book, article, brochure or printed advertisement.

Fees: Fee for Usage.

7. To facilitate or support Tarot readings delivered by a human being, including electronic reproduction of Tarot images to display Tarot cards to illustrate or facilitate the results of phone or email reading services.

Fees: Free of charge with attribution.

8. Images to be used in self-service, computer-automated Tarot readings -- via software or websites - Fees: Fee for Usage.
